- Laurie has stepped down as Hospitality chairman; we need someone or a committee to handle this important job.

Financial Report:

- Sasha Varsanofieva was elected Treasurer

Annual Treasurer's Report
FY 2011/2012

For the FY 2011-2012 we netted \$6,122.25. The checking account balance at the yearend was \$13,654.35. The account balance at the beginning of the year was \$26,691.67. In January, 2012 we moved \$10,000.00 from the checking account into the Show Snow fund. We were also carrying 2 reserved accounts in the checking account that have now been broken out into dedicated savings accounts, which makes the treasurer's job much easier. Those 2 accounts have over \$6,000.00. I haven't yet calculated the net worth of the society at the end of the year but I think that it increased by about \$2,000.00.

The show total income was \$30,873.27, which was \$3,127.27 over budget. The expenses were \$23,176.56, which was \$2,346.44 under budget. That gives the show a net of \$7,696.71.

Our monthly operating expenses were \$5,649.13, which was \$3,110.00 over budget, mainly due to donations to the NE Judging Center and the Smithsonian. It also includes 2 years of picnic expenses. I haven't yet transferred money from the Conservation account to cover the Smithsonian donation, so this will actually drop by \$500.00. Speakers' fees and expenses were \$1,190.37, which was \$309.63 under budget. Again, we didn't spend anything on the library.

Our main auction brought in \$4,133.00, which was \$2,133.00 over budget.

One significant change that I made is that all of our financial records are now backed up in DropBox. That includes our QuickBooks files and all of the financial reports and bank statements for the last 4 years.

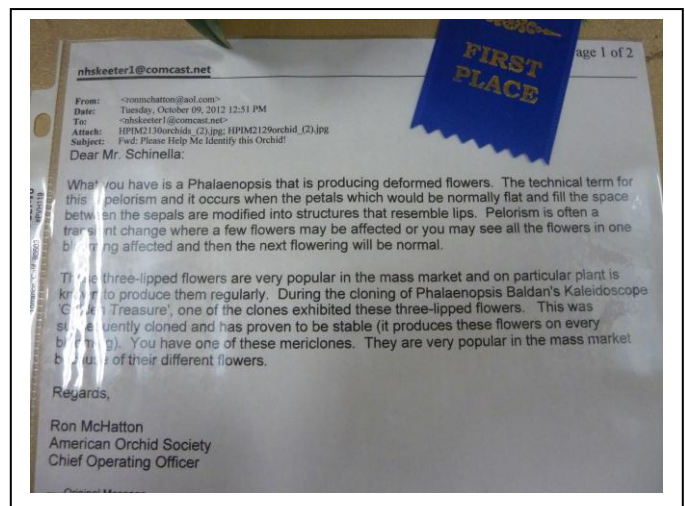

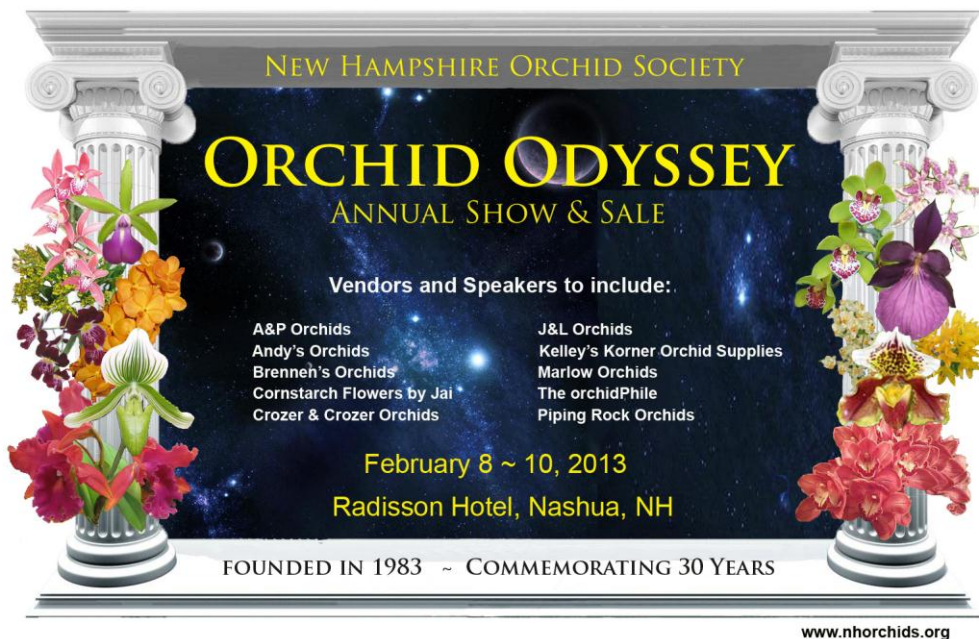
