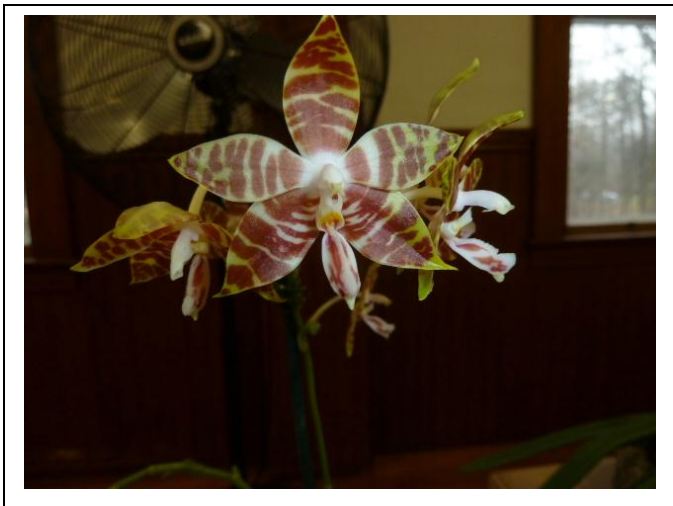

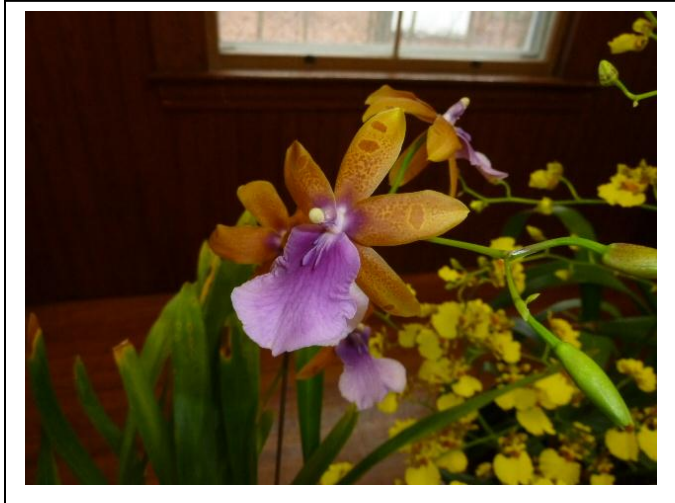

  - The Amherst Show is at the end of February; we still need a show captain.
  - Wentworth is at the beginning of March, captained by Mike and Ulla. We'll have ribbon judging.

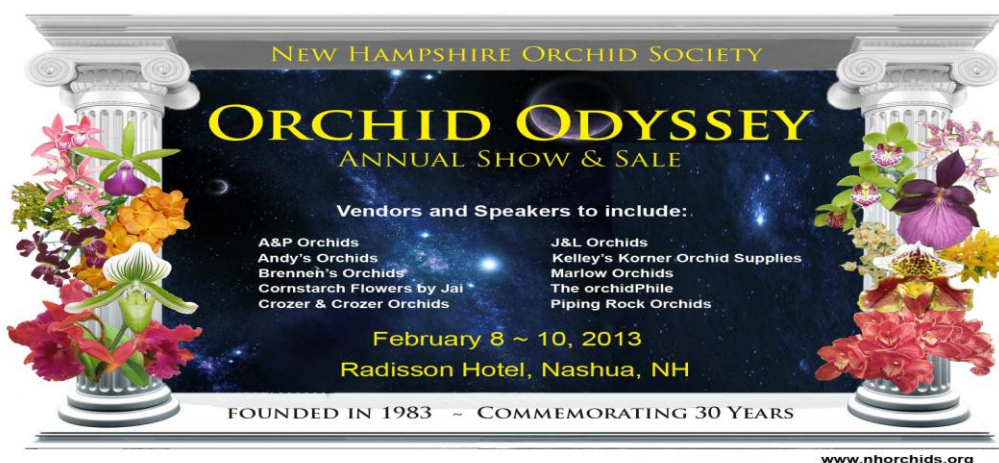


## January Program
